Regulations**

**\*IMPORTANT NOTICE\***

**Pursuant to Blackfeet Tribal Ordinance 121 ALL non-resident person(s) entering onto the Blackfeet Indian Reservation to hunt within the exterior boundaries of the Blackfeet Indian Reservation will adhere to the following:**

1. They must Self-Quarantine if traveling from, or through an infected area;
2. They must immediately notify Blackfeet Covid-19 Incident Command if they show/develop any symptoms of Covid-19 while on the Blackfeet Indian Reservation;
3. Must wear a mask at all times in public places on the reservation;
4. They must provide the Blackfeet Fish & Wildlife Department the name and address of where they will be staying while on the Blackfeet Indian Reservation, and they must disclose the names all persons within their hunting party;
5. Must Purchase their tags online at [blackfeetfishandwildlife.net](http://blackfeetfishandwildlife.net), or over the phone by calling the Blackfeet Fish & Wildlife Dept. at (406) 338-7202.
6. Non-Member & Non-Descendant Hunters must purchase their tags through a licensed outfitter.

7. Comply with all social-distancing, and CDC guidelines pertaining to Covid-19, and comply with the provisions established in Blackfeet Tribal Ordinance 121.

**OUTFITTER RESPONSIBILITIES**

It will be the responsibility of each Outfitter to ensure that:

1. The Outfitter and the Client(s) thereof are restricted from public places during their hunt;
2. The Outfitter is responsible for ensuring that face-masks are worn at all times, except when outdoors and where social-distancing is possible;
3. The Outfitter must provide Blackfeet Fish & Wildlife, and the Blackfeet Revenue Department:
  - 3A. The Name of their Client(s);
  - 3B. The Name(s) of any additional people traveling with the Client(s);
  - 3C. The date(s) their Client(s) will be on the Blackfeet Indian Reservation;
4. The Outfitter must take the temperature of themselves, their clients, and their client's party daily. A temperature higher than 100.4F in an adult, and a temperature higher than 99.5F is considered a fever.

5. The Outfitter must immediately notify Blackfeet Incident Command if they themselves, their client(s), or a person in their client's party shows/develops any symptoms of Covid-19, and the hunt must be postponed until incident command authorizes further activity.

## BLACKFEET FISH AND WILDLIFE DEPARTMENT 2020-2021 ANNUAL REGULATIONS Pursuant the Blackfeet Fish and Wildlife Code Chapter 2; Sec. 8 & Chapters 5, 7

**October 28, 2019**

Blackfeet Fish and Game Code enacted as Ordinance #118, codified at Chapter 16 of the Blackfeet Law and Order Code. All penalties cited in these regulations shall be cited as Fish and Game Annual Regulations "FWAR".

### AUTHORITY

**Section 1. Fish and Game Code 2-8(A), Annual Regulations.** The Blackfeet Fish and Wildlife Commission in collaboration with the Director shall develop and propose annual regulations as authorized by this Code, to the Council for approval. Season, quotas, cost of license/permit and special conditions shall be set in the Annual Regulations promulgated according to these rules. The Annual Regulations shall be published for distribution to the public by the Department.

### GENERAL HUNTING REGULATIONS

**Section 1. General Regulations:** The following regulations shall apply:

- A. No rifle authorized during bow season
- B. No hunting allowed ½ hour before sunrise to ½ hour after sunset
- C. Established hunting seasons are subject to change without prior notice, at the discretion of the Blackfeet Tribal Business Council.
- D. Only one animal per hunter during the Hunting Season (rifle and/or bow).

### LICENSE AND PERMITS MEMBERS/DESCENDANTS

**Section 1. Fish and Game Code Chapter 14, License and Permits.** (Please see full chapter)

**Section 2. Non-Refundable.** All tags are non-transferable, nor non-refundable.

**Section 3. Fish and Game Code 14-2, Tribal Member License/Permit.** Tribal members shall be issued licenses for big game, small game, special hunts, and bison hunts. Tribal members do not need fishing permits, except that they must carry a Tribal I.D. Tribal members can hunt and trap predators and furbearers without a permit. (Tribal members are not required to hunt with outfitter.)

- A. **Member General Hunting License:** \$20. The License will authorize the take of one (either-sex) Elk, two (either-sex) Whitetail Deer, and one Mule Deer buck with forked antlers or larger only.

1. **Antelope License:** A member can purchase a separate antelope license (one only) for \$5.
2. **Black Bear License:** A member can purchase separate black bear license (one only) for \$5.
3. **Gray Wolf License:** A member can purchase a separate gray wolf license (limit of three per person) for \$5. All harvested animals must be inspected by a game warden within 24 hours of take. Trapping illegal.
4. **Mountain Lion License:** A member can purchase a separate mountain lion (either sex) license for \$5.
5. **Mountain Goat License:** A member can purchase a separate Mountain Goat (either sex) license for \$10.
- B. **Elderly Members:** Blackfeet Tribal members over the age of 65 will receive a General Hunting Permit free of charge. Individuals claiming such permits will be allowed vehicle access into certain hunting zones. If an elderly tag holder is using helpers, the helpers cannot possess firearms in Zone 2A East. The tag holder can have up to 2 helpers, they must be a Member and/or Descendant.
- C. **Elderly member and Elderly Handicap:** No charge for subsistence hunting
- D. **Disabled Members:** Members with a disability must provide the Department a current Montana or other appropriate State Blue or Red Placard or provide a vehicle registration with such status. Disabled Member permits are \$20..
- E. **Member Spouse:** Member Spouse General Hunting License \$30. The license will authorize the take of one cow elk and one whitetail deer (either sex). Member Spouses are not eligible for special lottery tags.
- F. **Descendants:** Descendant General Hunting License \$25. The license will authorize the take of one cow elk and one whitetail deer (either sex). Descendant is not eligible for special lottery tags. Spouses of Descendants are not eligible for hunting license.
- G. **Elderly Descendants:** Elderly Descendants over the age of 65 can purchase a General Hunting Permit for \$20. Individuals claiming such permits will be allowed vehicle access into certain hunting zones. If an elderly tag holder is using helpers the helpers cannot possess firearms in Goose Lake area. The tag holder can have up to 2 helpers. Helpers who must be a Member and/or Descendant
- H. **Elder Descendants:** Elderly descendants over the age of 65 can purchase a Subsistence General Hunting Permit for \$20.00. Individuals claiming such permits will be allowed vehicle access into certain hunting zones. If an elderly tag holder

is using helpers, the helpers cannot possess firearms in Zone 2A East. The tag holder can have up to 2 helpers, they must be a Member and/or Descendant.

- I. **Disabled Descendant:** Subsistence General Hunting Permit is \$20. The tag holder can have up to 2 helpers;. Helpers must be Tribal Member and/or Descendant.

### NON-MEMBER HUNTING Pursuant the Blackfeet Fish and Wildlife Code Chapter 2; Sec. 8 & Chapters 5, 7

**Section 1. Non-member Tags.** Non-Members may purchase a Non-Member Special Big Game Hunting License Tag and are required to hunt with an approved Department Licensed Outfitter.

**Section 2. Non-member Big Game Hunt License.** The following big game tags are authorized:

- A. Bull Elk (brow tined) - **5 tags** are available at a minimum of \$12,000; (Zone 1, 2 & 3)
- B. Elk (cow) - **Are not** available for the 2020-2021 Season.
- C. Whitetail Deer (either sex) - **5 tags** are available at \$1,500 each
- D. Mule Deer (Bucks) - **5 tags** are available at \$1,500 each.
- E. Spring and Fall Black Bear - **10 tags** are available for \$1,500 each
- F. Moose - **5 tags** are available for \$14,000 each
- G. Antelope - **5 tags** available for \$1,000 each
- H. Bighorn Sheep - **1 tag** sold by bid starting at \$30,000 each – (every other year)
- I. Mountain Lion Tags - **10 tags** are available for \$500 each
- J. Mountain Goat - **1 tag** for sale at \$5,000 each
- K. Gray Wolf – 10 tags are available for \$300 per tag each

- **Rifle Season** - 2<sup>nd</sup> Saturday of October to the 3<sup>rd</sup> Sunday of December

- **Bow Season** – 1<sup>st</sup> Saturday of September to the 2<sup>nd</sup> Friday of October

**Hunting in Zone 3 will close on the 1<sup>st</sup> Sunday of February to the 3<sup>rd</sup> Sunday of July.**

- Bow hunting **Members/Descendant** only – 1<sup>st</sup> Saturday in September to 2<sup>nd</sup> Friday of October

##### B. Whitetail Deer (either sex)

###### Zone 1

- Closed- except for special lottery hunt(s)

###### Zone 2

- **Bow Season** – 1<sup>st</sup> Saturday of September to the 2<sup>nd</sup> Friday of October
- **Rifle Season** – 2<sup>nd</sup> Saturday of October to the 3<sup>rd</sup> Sunday of December

- Hunting, after General Hunting Season, Zone 3 stays open to Tribal Members only. No hunting tags required, antler/horn only. Harvested animals must be reported the Department within 24 hours of take.  
**Hunting in Zone 3 will close on the 1<sup>st</sup> Sunday of February to the 3<sup>rd</sup> Sunday of July.**

- Bow hunting **Members/Descendant** only – 1<sup>st</sup> Saturday in September to 2<sup>nd</sup> Friday of October

- Closed-except for special lottery hunt(s)

# BLACKFEET FISH AND WILDLIFE ANNUAL HUNTING ZONE and STAGING AREA REGULATIONS 2020-2021

## HUNTING ZONES. Fish and Game Code 6-1(B), Designated Hunting Zone

**Zone 1.** Boulder/Flattop Area and west side of Lower St. Mary Lake. Beginning from the community of St. Mary West to Glacier National Park Boundary continuing North to Sherburne Dam and the Many Glacier Roadway following the road to East and North across Moccasin Flat to the St. Mary River, continuing South back to the Bridge on Highway 89 on the South end of Babb Flat and following the Highway back to St. Mary.

**A. Rules:** This area closed to vehicle use (no mechanized or motorized use year round). This area will be restricted to foot and/or horseback use only. Hunting season established. **Fine-\$1,000.00**

**B. Rules:** Carrying of long gun illegal; exceptions holder of Special Lottery tag and/or Non-Member Special Hunting tag. **Fine-\$1,000.00**

**Zone 2.** The area along the Rocky Mountain front, beginning on the North end of the North Fork

Ranch road, and continues South to the roads intersection with Highway 464 Duck Lake Road, continues South into Browning and follows Highway 89 South, to the Southern boundary of the Reservation at Birch Creek. Birch Creek West to Swift Dam and running North back to the Canadian Border adjacent to Glacier National Park.

**Zone 2A West.** Tower Ridge, Yellow Mountain and Chief Mountain areas, North of Many Glacier Road, to Glacier National Park Boundary, West of Highway 89 and South of Highway 17.

**A. Rules:** This area closed to vehicle use. All hunters will park at Staging Area. Area is closed to motorized vehicles (including ATV's) during general hunting season. This area will be restricted to foot and horseback use only. **Fine-\$1,000.00**

**Zone 2A East.** Starting at the Junction of Highway 89 and Montana 464 at St. Mary River Bridge, follow Highway 89 North to the Junction of Camp Nine Road and follow the road East to the North Fork Ranch road to Junction of Montana 464.

**A. Rules:** This area is closed to vehicle use. All hunters will park at Staging Areas. Area is closed to motorized vehicles (including ATV's) during

general hunting season. This area will be restricted to foot and horseback

only, and is designated as a special hunting zone for elderly to enter by use of motorized vehicles (including ATV's). **Fine-\$1,000.00**

**Zone 3.** All lands on the Eastern part of the reservation, East of the following roads: North Fork Ranch Road North straight to the Canadian Border and East of Montana 464 and Highway 89 to the Southern Boundary of the reservation.

**A. Rules:** Zone 3 is a Special Subsistence Hunting Area. Subsistence hunting is allowed after general hunting season for the harvest of antler bull or buck, closing 1st Sunday of March through 3rd Sunday of July. No tags required, but all takes must be reported to the Department within 24 hours. **Fine-\$1,000.00**

**Zone 4.** All Lands South of BIA Route 2, (East Glacier to Heart Butte Cut-Across Road) beginning with its intersection of Highway 2 just West of East Glacier, continuing East towards the Junction of the Dog Gun Lake Road, South to the Lewis and Clark National Forest Boundary and back North to Highway 2.

**B. Rules:** Zone 4 is designated Bow hunting for Tribal Members/Descendants only. **Fine-\$1,000.00**

**C.** Rifle Hunting in Zone 4 may be available by lottery draw as outlined in the Blackfeet Fish and Wildlife Annual Regulations.

## STAGING AREAS. Fish and Game Code 6-1(C), Designated Hunting Staging Areas.

Areas established and subject to such conditions as may be determined by Annual Regulations promulgated pursuant to these rules. **Fine-\$500.00**

Hunters must park at posted Staging Areas and shall either walk or ride horseback into the specific hunting zones. Hunters are restricted from driving through Staging Areas.

**Zone 1:** The only staging areas designated for this Zone shall be at the Iron Gate on the north end of the Lower St. Mary Lake's

west shore road and the Little Canada turnout on the Many Glacier Roadway.

**Zone 2:** Restricted vehicles access is allowed for elders only.

### (i) Zone 2A (West):

#### a) Chief Mountain Road Staging Areas – Montana Highway 17:

Across the road from Burns Sawmill, Slide Lake Road by cattle guard east of Crusher Hill Pullout and approach across from Bob Fullerton's place.

#### b) Yellow Mountain Staging area: Kennedy Creek crossing south of fence line (near Glacier National Park boundary) and north of Tower Ridge and picnic table.

#### c) Many Glacier Road Staging Area: Little Canada turnout and Camp 5 turnout.

### (ii) Zone 2A (East):

#### a) Duck Lake Head Bay Staging Area: West end of Duck Lake.

#### b) Spider Lake Staging Area: Anywhere along the canal road east of Spider Lake and west of Iron Bridge crossing on St. Mary Canal.

#### c) North Fork Road Staging Area: Near the garbage bin along the road a mile north of the Duck Lake Road.



# BLACKFEET FISH AND WILDLIFE ANNUAL TRAPPING, FISHING, and BIRD HUNTING REGULATIONS 2020-2021

## FURBEARER TRAPPING

**Section 1. Member Trapping License Cost, Trapping Season, Non-Member Special Trapping and/or Predator Control License:** (any furbearer being taken off the reservation shall need an Export Permit)

**Section 2. Logs Required.** Trappers must provide a trapping log to the Department for all furbearers harvested.

**Section 3. Members and Descendants License.** Trapping License Cost – Members and Descendants can purchase a furbearer trapping license for \$5. Zone 2 and Zone 3 only.

**Section 4. Non-member License.** Non-member Special Trapping and/or Predator Control License Cost – A non-member can purchase a Special Trapping and/or Predator Control License for \$100 (beaver only) (coyotes hunted only). Zone 2 and Zone 3 only, and will need landowner permission.

**Section 5. Trapping Season.** Trapping season starts on the last Monday of September until April 30<sup>th</sup>.

- A. Closed Species. Wolverine, lynx, bobcat, swift fox, fisher: Closed – On list, Blackfeet Endangered and/or Threatened Species
- B. Season. Weasel, muskrat, beaver, pine marten, mink, coyote, red fox, raccoon, otter, badger and skunk: September 15th through April 30<sup>th</sup>

## CHAPTER 8-FISHING

**Section 1. Watercraft – Per Ordinance 113A,** all watercraft (motorized and non-motorized), float tubes, rafts, flippers, waders, etc. must be inspected for Aquatic Invasive Species before launching or entering Reservation water.

**Section 2. Line and Hook Method.** Commercial Gill Netting is prohibited.

**Section 3. Non-member Fishing License.** Rates:

- A. Daily Fishing License - \$20(valid for purchase day only)
- B. 3-Day Fishing License - \$45 (valid for (3) three consecutive days only)
- C. Annual Fishing License - \$75 (April 1 – March 31)
- D. Member/Descendant Spouse annual fishing license- \$30
- E. Discounted Permit: Medical, Law Enforcement, and Fire Management Personnel providing essential services to the Blackfeet Nation- \$30.00
- F. Annual Recreation/Conservation - \$20 (April 1 – March 31) Prices may change with Council approval.

**Section 4. Non-member Fishing Season and Hours.**

- A. Rivers and Stream Fishing Season – The river and stream are open to non-member fishermen on the 3<sup>rd</sup> Saturday

in May until November 30.

- B. Lakes and Reservoirs – Lakes and Reservoir fishing is open all year unless otherwise stated by the Blackfeet Fish and Wildlife Code or Regulations.
- C. Fishing Hours: No one shall begin fishing until ½ hour before sunrise until ½ hour after sunset. In addition, no watercraft or ice fishing house shall be on a lake during closed hours.

## Section 5. Fish Species Daily Limits.

SPECIES/categories	DAILY POSSESSION LIMIT
Trout (includes Rainbow Trout, Brown Trout, Cutthroat, and Arctic Grayling)	Daily – 3 fish only 1 may be over 20 Inches and only 1 fish may be Brown Trout
Brook Trout	Daily – 5 only 1 may be over 13 inches Exception: At Dog Gun Lake only 1 Brook Trout may be retained and it must be 13 inches or greater
Bull Trout	All waters are closed to Bull Trout angling (Except for Duck Lake in which harvested Bull Trout will be included in the Daily Trout Limit

**CAUTION: Some Lakes may have Aerators** – Open water and poor ice conditions may occur during winter months. It shall be unlawful to interfere with, retrieve or molest any BFWD net, trap, weir, buoy, or other piece of equipment or property.

## BIRD HUNTING

### Section 1. Upland Game Bird Hunting

- A. Limits – The Daily Limit shall be 5 total: which may consist of no more than 5-Hungarian Partridges, 3-male Ring Necked Pheasants, 3-Ruffed Grouse, Sharp Tail Grouse, Blue

Grouse, or Spruce Grouse. Possession limit is 2 times/daily limit. One wing must remain naturally attached to carcass for identification.

- B. Hunting Zones  
Zone 1 – Closed  
Zone 2 – 1st day of September through January 1st, Except for male Ring Necked Pheasant which is October 2nd through November 30th.  
Zone 3 – 1st day of September through January 1st, Except for male Ring Necked Pheasant which is October 2nd through November 30th.  
Zone 4 – Closed

### Section 2. Migratory Waterfowl

- A. Seasons and Limits. Set by Federal Regulations which the Blackfeet Tribe has adopted. All Migratory Waterfowl Hunter shall refer to the Federal Pacific Flyway Regulations, which will be available at Blackfeet Fish & Wildlife Office.
- B. Ducks (including Mergansers). Bag limit: Daily bag limit shall be 7 ducks or mergansers. Daily bag limit shall not include more than 2 hen mallards, 1 pintail, 2 redheads, 2 canvasbacks and 3 scaup. Scaup season closes Dec 24. The possession limit may not exceed three times the daily bag limit of any species and sex.
- C. Coots. Bag limit: 25 daily and in possession.
- D. Geese. Daily limit: 5 white geese (Snow, Blue, Ross's) and 4 dark geese (all other geese). The possession limit is three times the daily limit.
- E. Migratory Waterfowl Hunting Zones/Season  
Zone 1 – Closed  
Zone 2 – Federal Pacific Flyway Regulations apply  
Zone 3 – Federal Pacific Flyway Regulations apply  
Zone 4 - Closed
- F. License Cost for Upland Game/Migratory Waterfowl hunting –
  1. All Migratory Waterfowl Hunters shall purchase Federal Migratory Duck Stamp
  2. Non-Member, Non-Montana Resident permits \$120.00
  3. Non-Member Montana Resident \$60.00
  4. Blackfeet Tribal Members – no cost

# BLACKFEET FISH AND WILDLIFE ANNUAL SPECIAL LOTTERY, HABITAT PROTECTION, and RECREATION/CONSERVATION REGULATIONS 2020-2021

## SPECIAL LOTTERY HUNTING TAGS pursuant Blackfeet Fish and Wildlife Code Chapter 14;1(D)

**Tribal Members and Descendants can purchase lottery chances on-line or at the Blackfeet Fish and Wildlife Office (406) 338-7207. Drawing results will be posted on October 28<sup>th</sup>, 2019**

### Member Moose Lottery:

- A. A special number of moose tags will be available through a lottery draw for the reservation. The cost will be \$5 per chance, with a limit of \$200 per person.
- B. There will be three moose lottery tags drawn the day before **bow hunting season** opens.
- C. There will be five moose lottery tags drawn the day before **rifle hunting season** opens.

### Member Elk Lottery:

- A. A special number of elk tags will be available through a lottery draw for Zone 1 (Boulder/Flattop Area) and Zone 4 (bow hunting only). The cost will be \$5 per chance, with a limit of \$200 per person.
- B. There will be three elk lottery tags drawn the day before **bow hunting season** opens (successful bow hunter will be unable to acquire a general elk tag during rifle season).
- C. There will be five elk lottery tags drawn the day before **rifle hunting season**.
- D. There will be 5 elk lottery tags drawn before **rifle season** for Zone 4

**Member Big Horn Sheep Lottery:** (Per policy, Bighorn Sheep will be hunted every other year):

- A. One Big Horn Sheep tag will be available. The cost will be \$10 per chance, with a limit of \$500 per person. There will be one lottery tag drawn the day before **rifle hunting season** opens. Lottery tag recipient will be allowed two "helpers" to assist them with retrieving the harvested Big Horn Sheep out of Zone 1. The helpers must be Tribal Members and/or Descendants and have proof of membership on their person while helping.

### Mule Deer Rut Hunts:

- A. There will be 3 Tribal Member tags available
- B. There will be 3 descendant tags available
- C. Each Lottery tag will cost \$10.00 per chance with a limit of \$200 per person.
- D. Season runs from November 1<sup>st</sup> through November 30<sup>th</sup>
- E. Valid in all zones

### White-Tailed Deer Rut Hunts:

- A. There will be 3 Tribal Member tags available
- B. There will be 3 descendant tags available
- C. Each Lottery tag will cost \$10.00 per chance with a limit of \$200 per person.
- D. Season runs from November 1<sup>st</sup> through November 30<sup>th</sup>
- E. Valid in all zones

## HABITAT PROTECTION – SPECIAL WILDLIFE MANAGEMENT AREAS AND RESTRICTIONS OF THOSE AREAS pursuant the Blackfeet Fish and Wildlife Code Chapter 13;Sec. 10

**Section 1. Special Management Areas.** Hunting is prohibited year round in the Boulder- except for special lottery hunting Ridge/Flattop Area (Zone 1) and Dog Gun Area (Zone 4).

### Section 2. Special Management Area Access.

- Zone 1 – No motorized/mechanized access (foot or horseback only)
- Zone 4 – Member bow hunting only.

### Section 3. Carrying a long gun (rifle).

- Long guns (rifle) are illegal in Zone 4; Exception - Zone 4 Access for Members and Descendants only, when crossing Blackfeet Reservation to access Montana Hunting District 415.

### Section 4. Harassing Wildlife/Antler Hunting and Gathering of Wildlife Parts.

- No person shall drive or harass any antlered animals to make antlers fall off wildlife
- No antler hunting before April 1<sup>st</sup>.
- Antler hunting is prohibited for Non-members
- All antlers taken off reservation must have an export permit.
- All buyers, of antlers and horns, must have a **Blackfeet Tribal Business License**.

### Section 5. Flattop Lake and Flattop Area.

- Fishing is permitted, except during the general hunting season.
- Area closed to motorized vehicles, enter by horseback or foot only.

**Section 5. Grazing Permits.** No livestock grazing permits will be issued in Special Wildlife Management Areas.

### Section 6. Gathering of Animal Parts.

- Only Members and Descendants can gather, retrieve or hunt antlers and/or gather wildlife parts on the Blackfeet Reservation. It shall be illegal for anyone to hunt/gather Bighorn Sheep horns or skulls on the Blackfeet Reservation.

## RECREATION/CONSERVATION PERMIT COST AND RECREATION ACTIVITIES- pursuant the Blackfeet Fish and Wildlife Code

### Section 1. Recreation/Conservation

**Permit Costs.** This permit allows non-members to recreate on the Blackfeet Reservation. Per Blackfeet Tribal Business Council, shall restrict and/or close any area of the Reservation as needed for safety, over-use and wildlife management reasons.

**Section 2. Members and Descendants.** No cost.

### Section 3. Non-Member

**Recreation/Conservation Permit.** The cost is \$20, which permits the user recreational access on the Blackfeet Lands.

### Section 4. Recreational Vehicle Permit

**Cost.** The cost is \$50, which permits the user recreational vehicle use on the Blackfeet Reservation. Permit is for recreational vehicle use only on established two-track roads and landowner permission required; decal provided.

### Section 5. Minors and All-Terrain Vehicles.

See "John's Law"

**Section 6. Outfitter required for Non-Tribal Members.** All Non-Tribal Members will have a Department approved Outfitter leading their group within the exterior boundaries of the Blackfeet Nation.

**Section 7. Prohibited ATV Activity.** No ATV or snow mobile shall be used in the retrieval of a harvested Big Game. Contact a Department Game Warden to verify harvested animal (gutting and tagged).

**Section 8. Windsurfing.** Four Horn Lake, Mission Lake, Duck Lake, and Lower St. Mary Lake shall be used for windsurfing.

**Section 9. Camping:** Camping shall not be permitted on the following:

- Private lands without the owner's permission.
- Along the Highway.
